Mary Ann Van Arsdale, Director, Institute for Entrepreneurial Studies

Ms. van Arsdale outlined the work of HACC's Institute for Entreprenurial Studies as it assists Central Pennsylvania residents in starting their own businesses. In 18 months the Institute has established itself as a "one stop" center for entrepreneurs to draw on a variety of resources, including assistance from the Small Business Administration, SCORE (the Service Corps of Retired Executives) and Murata Business Center. The Institute receives some 880 calls a month and meets a wide range of needs, from answers to basic questions about starting a business to consultation services or referral to local banks for start-up funding. The Institute's

"Women On The Move" program provides women entrepreneurs with a variety of resources for planning, financing and marketing new business ventures. This year more than 500 women participated in "Women On The Move."
